(1) Directly owned by Paperboy Ventures, LLC, a Delaware limited liability company. Mr. Allen Andersson is the sole member of Paperboy Ventures, LLC and may be deemed to have shared voting and dispositive power with respect to such shares.

#### Item 1. Security and Issuer

The name of the issuer is Corcept Therapeutics Incorporated, a Delaware corporation ("Issuer"), which has its principal executive offices at 149 Commonwealth Drive, Menlo Park, California 94025. This statement relates to Issuer's common stock, \$0.001 par value per share ("Common Stock").

#### Item 2. Identity and Background

This Schedule 13D is being filed on behalf of:

- (a) Paperboy Ventures, LLC (the "Reporting Person").
- (b) 1875 K Street, N.W., Suite 700, Washington, DC 20006.
- (c) The principal business of the Reporting Person is business investment.
- (d) During the last five years, the Reporting Person has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).
- (e) During the last five years, the Reporting Person has not been party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.
- (f) The Reporting Person is organized under the laws of the State of Delaware, United States of America.

#### Item 3. Source and Amount of Funds or Other Consideration

On November 8, 2007, November 9, 2007 and November 12, 2007, the Reporting Person used working capital of \$165,506.50 to acquire an aggregate of 60,000 shares of Common Stock.

#### Item 4. Purpose of Transaction

The purpose of the acquisition of the Common Stock is for general investment purposes. In addition, the Reporting Person may from time to time, depending on prevailing market, economic and other conditions, acquire additional shares of the Common Stock of the Issuer or engage in discussions with the Issuer concerning further acquisitions of shares of the Common Stock of the Issuer or further investments in the Issuer. The Reporting Person intends to review its investment in the Issuer on a continuing basis and, depending upon the price and availability of shares of the Common Stock, subsequent developments affecting the Issuer's business and prospects, other investment and business opportunities available to the Reporting Person, general stock market and economic conditions, tax considerations and other factors considered relevant, may decide at any time to increase or to decrease the size of its investment in the Issuer.

Except as set forth in this Schedule 13D, the Reporting Person has made no proposals, and has entered into no agreements, which would be related to or would result in any of the events or matters described in part (a) through (j) of Item 4 of Schedule 13D.

#### Item 5. Interest in Securities of the Issuer

- (a) According to the Vice President and Controller of the Issuer, there were 39,548,489 shares of Common Stock issued and outstanding as of November 12, 2007. Based on such information, Paperboy directly owns 8,345,383 shares of Common Stock of the Issuer, representing approximately 21.10% of the issued and outstanding shares of such class.
- (b) The Reporting Person has the sole power to vote and dispose of -0- shares. The Reporting Person has the shared power to vote and dispose of 8,345,383 shares. Allen Andersson, as the sole member of Paperboy, may be deemed to have shared voting and dispositive power with respect to such shares.
- (c) On August 16, 2007, the Reporting Person used working capital of \$2,000,000 to acquire 952,380 shares of Common Stock pursuant to a Stock Purchase Agreement dated August 16, 2007 (the "Purchase Agreement"), between the Issuer and the purchasers named therein. On September 24, 2007, the Reporting Person used working capital of \$2,500,000 to acquire 1,190,476 shares of common stock. Except as disclosed in this 13D, the Reporting Person did not effect any transactions in the Issuer's securities within the past 60 days.

The shares of Common Stock sold and issued on September 24, 2007 in connection with the Purchase Agreement have not been registered under the Securities At of 1933, as amended, or any state securities laws and may not be offered or sold in the United States absent registration with the Securities and Exchange Commission or an applicable exemption from the registration requirements. As part of the transaction, the Issuer has agreed to file a registration statement with the Securities and Exchange Commission for purposes of registering the resale of certain of the shares of Common Stock issued in the private placement within two business days following the filing of its Form 10-K for its fiscal year ending December 31, 2007.

Except as disclosed herein, there are no contracts, arrangements, understandings or relationships (legal or otherwise) among the Reporting Person and any other person with respect to any securities of the Issuer, including, but not limited to transfer or voting of any of the securities, finder's fees, joint ventures, loan or option arrangements, puts or calls, guarantees of profits, division of profits or loss, or the giving or withholding of proxies.
